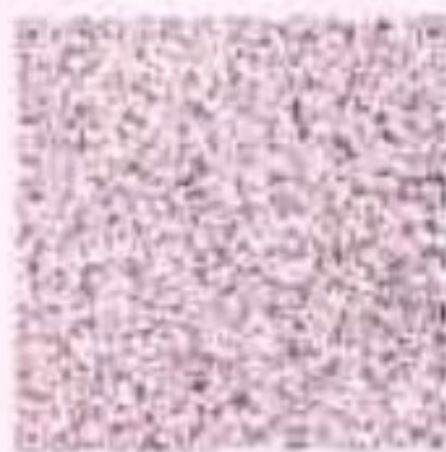

CHHITAUNI, Post- MURIYARI, Dist- BALLIA, UP, India, PIN- 277202, herein after called as setter (which expression shall unless extended by or repugnant to the context be deemed to include setter executor, administrators and representative) of one part and constitute a trust and nominate following persons as trustees.

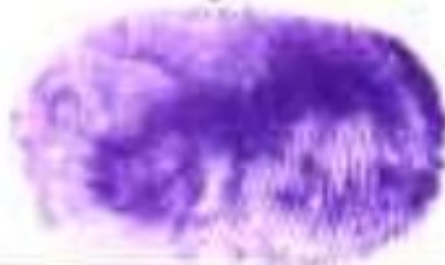

The trust may and will carry out of other such activities as listed in the objectives of this trust deed.

With the above motives and for the social cause of well being or the people of all the caste, community and religion, the fonder trustee along with the co-founder author wish to create this trust. In the opinion of the founder trustee, the work will done by this trust will help the community to set up the better standard of living there by strengthen the process of social and economical development. In this way the trust will be able to serve the nation by establishing, school, collages, technical collages/medical collages, management institutes and hospitals dispensary and any other institution for the well being of people at large.

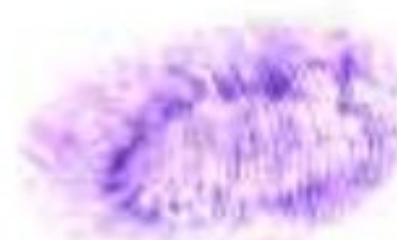
Whereas the above fonder trustee/chairman has contributed a sum of Rs. 100000/- for creation of this trust out his own funds/having. Initial money shall be called as preminary "Trust Fund" (Total Rs. 100000/- only). The author/founder and other member trustees which may be appointed may and will contribute any other sums including gifts of any assets form to me to make the new institutions running.

That in order to make trust functioning legally and as per the rules and regulation the objective and by law of the trust have been formulated and declared as given herein under:-

1. **Name of the Trust:** That the founder Trustee declared that the name of the trust shall be "PATO DEVI MEMORIAL TRUST".
2. **Registered Office:** That is registered office will be at Vill- Chhitauni, Post- Muriyari, Dist- Ballia, UP, India, PIN- 277202 or at such place or places as the trustee may decide from time to time till the trust has its own building.
3. **Administrative Office:** That is administrative office will be at Vill- Chhitauni, Post- Muriyari, Dist- Ballia, UP, India, PIN- 277202 or at such place or places as the trustee may decide from time to time till the trust has its own building.
4. **Type of Trust:** That the trust shall be a charitable trust, it shall be open for every person, irrespective of his caste, creed or religion.
5. **Area of Operation:** That the area of operation of the above trust shall be throughout INDIA and Abroad.
6. **Aims and Objectives:** That the main objective of the trust will be to provide education from basic to higher, technical, medical and management education including medical services and any possible relief to poor and needy. The activities shall be carried out for charitable purpose not for the purpose of profit. The aims and objectives of the trust shall be as follows:-
  - 6.1 To spread and promot education (Basic, higher, medical or technical education) and learning in all its branches in such manner (carries oriented education) as the trustees my think fit.
  - 6.2 Education for all in any trade including technical and medical field.
  - 6.3 To establish and run school(s), collage(s) including running of graduate and post graduate course in the field of social science, art, science, engineering and medical.

- 6.4 To establish and run carrier obtained course, diploma in any technical field including computer education.
- 6.5 To establish and run technical institute like I.T.I., polytechnic in the rural and remote areas as to develop technical knowledge and skills to the rural.
- 6.6 To establish and run graduate and post graduate collage(s) for B.Ed., B.T.C. and M.Ed. etc.
- 6.7 To establish and run law collage covering various courses in the related field.
- 6.8 To establish and run university for national and international education.
- 6.9 To establish paramedical collage including various paramedical and nursing courses.
- 6.10 To establish and run the school for desk and dump.
- 6.11 To establish collage of journalism including of various courses in the relevant fields.
- 6.12 To establish and run old age home for shed and destitute person.
- 6.13 To establish training institute to impart training regarding knowledge skills and aptitude in the various fields of agriculture, horticulture, fishers, animals husbandry and dairying other rural trade in the rural areas for getting suitable employment or self employment.
- 6.14 To establish run and maintain and/ or construct hostel, boarding house and to grant free/ concessional boarding and loading to poor and reserving students.
- 6.15 To take over the management and administration of medical instituting/ hospitals of the aforesaid nature already establish will all their assets and liabilities.
- 6.16 To assist students who are preparing for entering upon or engaged in any discipline, profession, trade occupation or services by outright gifts or payment

of fees, payment of traveling expenses or by such other means for advancement to uplift their own living.

- 6.17 To establish, construct, or maintain or support library for basic/ higher, medical, technical, education, B.Ed./ M. Ed., courses and advancement thereof.
- 6.18 To establish, promote, institute, support, development and encourage various institution and center, funds, trusts, academics,, association for the purpose of innovations, developments and research in all branches of technical/ medical sciences.
- 6.19 To acquire, buy purchase and take on lease, hire or transfer by license or otherwise any land, building or other property. (moveable or immoveable assets) or right over or connected therewith.
- 6.20 To lease of let on hire, mortgage, sell pledge or transfer by license or otherwise any land, building or other property (moveable or immoveable assets) for the proposes of its objects.
- 6.21 To construct building or buildings or other structures on land acquired by the trust in any manner.
- 6.22 To accepts gifts, donation etc. of any nature whatsoever.
- 6.23 To take over, mange associate or to combine with any institute of the nature aforesaid.
- 6.24 To draw, make, accept, endorse, discount, execute and issue cheques, promissory notice, bills of exchange or other negotiable or transferable instruments.
- 6.25 To open bank accounts of the trust with the nationalized/ scheduled bank.
- 6.26 To receive grant-in aid, in cash or in other from central or state government, charitable institutions, trust university and/or other academy institution, Indian

industry and individuals within the country and from united nation other international institution and/or/private/public/origin bodies etc.

- 6.27 To borrow or advance money for the purpose of trust on such trust and conditions (including mortgage of land, building or any other immovable property of the trust) as the board of trustees thinks fit.
- 6.28 To establish and maintain any institutions for cadre of selfless and devoted workers who dedicate there lives for carrying our and promoting the aims and objects of the trust and to train such workers from the better service.
- 6.29 To do all other things as or incidental to or may be conductive to the attainment of the above objects.
- 6.30 To assist in rehabilitant destitute boys, girls, old age and women also making them self reliant and to provide them health and educational facilities.
- 6.31 To work every possible way to bring up the life and times on downtrodden and destine women, men, children and old age.
- 6.32 To work upon the comprehensive actions plans in order to get rid of various bad aspects and superstitions prevailing in the society.
- 6.33 To encourage and develop the human values among the people in order to build up a healthy citizenship and harmonious society.
- 6.34 To create, collect and publish mature which is encouraging and committed towards development.
- 6.35 To works on programs in every possible way which the forced towards environment protections and to run group plantations programmer.
- 6.36 To help in every possible way to the victim of nature disasters.
- 6.37 To create a filling of self reliance among young and girls by providing them training in the field of sports and health education.

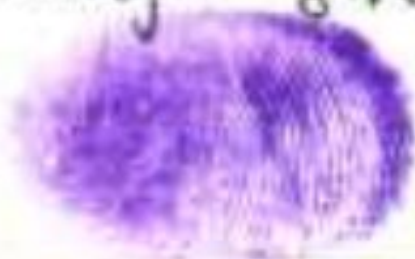

- 6.38 To implement and run programs with the assistance of khadi village industries commission and encourage the khadi village industries movement.
- 6.39 To organize or time cultural program, seminars and workshop etc. for building up the capacity of people of various, government departments involved in various projects of development so that can be motivated and oriented towards the project activities in a better way.
- 6.40 To fix and obtain appropriate fees and cost for various products and services being provided by the trust.
- 6.41 To manage enhance and recognize the property of the trust in order to fulfill the aims and objects of the trust.
- 6.42 Trust would invest all its profit and income for the welfare of the people.
- 6.43 To go on international visit for cultural and social studies.
- 6.44 To run refresher course for service for service and also to people who are in the government service so that there capacity can be build up in an effective manner.
- 6.45 To create feeling of brotherhood among dalits and general casts people and cast able better relationship.
7. **THE TRUST FUND:** That the "trust fund" shall comprise of presently the above sum of Rs. 100000/- only and in future.
- (a) Any movable / immovable property and money by way of gift or otherwise which the founder trustees my receive from time to time and deliver to the trust.
- (b) All fees and other charges received.
- (c) All money provided by the state or central government under grant.
- (d) All money received by way of grants, gifts, donations, benefactions and bequests of transfer or.

**PROVIDED** that benifictions which in its opinion involves conditions or obligations opposite to the spirit and objects of the trust shall not be accepted by the trust.

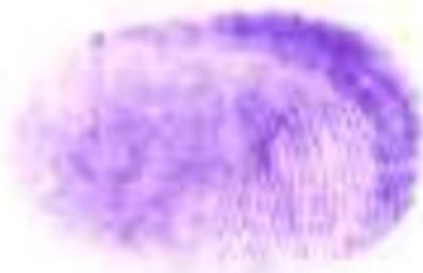
**PROVIDE FURTHER** that out of the any money or sums received (as listed a to above) which or of the nature for corpus fund shall not form part of the trust fund. Such sum shall be created to the corpus fund not shall be applied for the purpose for which such sums were received.

**8. PROVISION RELATED TO FULFILLMENT OF OBJECTS OF THE TRUST:**

The following provisions shall govern that in fulfillment of the objects of the trust:-

- (a) No part of the trust fund of corpus fund shall be applied for any purpose, which is not in furtherance of the charitable purpose and objects of the trust.
- (b) Only the income by and out of the trust fund and not that of the corpus fund shall be used to meet the running expenses of the trust.
- (c) The trustees may convert the corpus fund from the from to another without changing intends of the donor/payee and may invest such sums any of the securities as maintained in section 23 of the Indian trust act 1882.
- (d) All movable and immovable properties of the trust or that visiting in the trustee shall be transfer by the founder trustee/chairman or the person authorized by him/her in writing. This conditions shall not apply if any property of the trust to donated to any other trust society/institutions of the same nature, if approved by the founder trustee/chairman. Provided further that notwithstanding to provision of this clause. The trustee may borrow funds from any banks or financial institutions and mortgage any immoveable property of the trust, provision of his clause shall not restrict the power of such banker, financial

institutions/or any other financier to sale out/ auction the property in question in satisfaction of there dues, if the repayment is not normal course.

- (e) Any college, institution, hospital, dispensary, shelter home of the trust shall be open to person of either sex and or whatever caste, creed or class and no test or conditions shall be imposed as to relinquish there right in admitting student, patients or person and or in appointing me members, teaching staff, administrative staff and workers or any other connection whatsoever.
- (f) May fix and demand fees and other and charges to meet recurring and nonrecurring expenses of any institutions under the control management and institutions of the trust.
- (g) May create full or part time teaching, administrative, technical and ministerial posts on such wages, salary or remuneration, which should be reasonable vis-a-vis the jib requirement and may make appointment thereto.
- (h) The trust may pay salary, honorarium of remuneration to any of the trustee or member if such trustee/member renders regular/part time services to any of the instruction under the control and management of the trust. The trust may also pay setting fees including travelling expenses and allowances to the non working trustee for meeting attended by them.
- (i) The trustee may provide, accommodation, transportation and communication facility to any of the working trustee/trustee the terms and extent of the facility will be in accordance with the terms and conditions for there services to the trust excepted as provided no such facilities should be granted to any trustee/member with out charges.

The trust may also pay lense rent, hire charges on land, building and equipments etc. if provided to the trust by any of the trustee/member.

**9. Facilities to the Chairman/Founder/Trustee :**

1. Founder trustee/chairman will be provided with all facilities including residence, office, vehicle and communication. The quality and status of the facilities will be decided by founder trustee/chairman himself.
2. Founder trustee/chairman can draw salary/honorarium from the trust for discharging his duties. The amount which shall be decided by the chairman himself and will be binding to all.

**10. MEMBERSHIP:** That any individual above age of 18 years, who is in agreement with the aims and objective of the trust will be eligible for the membership subject to the approval of the board of trustees. A member other than the founder trustees will be called ordinary member.

**11. CESSATION OF MEMBERSHIP:**

- i. By voluntary resignation accepted by the board of trustees.
- ii. By death provided in case of death of a life time founder trustee is nominated person/successor/heir will step in as a member.
- iii. On account of unsoundness of mind.
- iv. By resolution of the board trustee in the case of a member other than life time trustee.

**12. REMOVAL FROM MEMBERSHIP:** That any member acting in any way prejudicial to the interest of the trust or in any manner likely to bring bad name to it may be removed from the membership by the resolution passed in the meeting of board of trustees.

Provided further that a founder trustee can be removed only if he/she accepts his/her removal in writing. In case of a dispute the matter shall be referred to the court.

**13. GENERAL BODY:** That the general body of the trust will consists of membership of board of trustee and ordinary member.

**14. BOARD OF TRUSTEE:** That for the management of the trust and to operate coordinate and administer the different units of the trust there shall be a directorate consisting of an executing body to be name as "Board of trustee". This body as exercise the work of supervision and direction and shall control all the units of he trust. Its income and property. All the movable or immovable properties of the trust will be visited in this body. This body shall not comprise of more than 10 members including the founder trustee as desiented office bearers (in case of a death of founder trustee his nominee/legal heirs and successor shall continue as the office boarer of this body). The founder trustee may nominee remaining members if so desired.

The board of trustee of the trust will consists of:-

- i. Founder trustee to be designated as chairman.
- ii. Chief trustee to be designated as vice chairman.
- iii. Co-trustee to be designated as director.
- iv. Co-founder trustee to be designated as general trustee / treasurer.
- v. Any other person nominated by the founder trustee shall be designated ex-office member.

**15. TERMS:** The terms of the founder trustee shall be for lifetime. Time term of founder trustee designated as chairman shall be for lifetime. There office will not be open for election however the terms of first board of trustees comprising of

other office bearers shall be for the three years and there after the destination of each trustee will be reviewed and finalized by majority vote of the board of the trustee. The terms of nominated member of the board of trustees shall be for one year thereafter a fresh nomination will be necessary for each year. The founder trustees reserve the right to nominated to any successor will right shall be exercise only in writing whether testamentary or otherwise. That is the duty of founder trustee/chairman to nominate his heir founder trustee/chairman during his life span either by mentioning it in the register of the register or by formulating his will. In case the will, the cast will formulated by him in the later part of his life will be reconised as his original will in case founder trustee dies without naming the successor, one of the descendent of the such person will take the place of the deceased and similarly after the death of such descendent, one of his descendent , and after the death of latter's death one of his descendent nominated as aforesaid, shall take the place of his deceased as a member of board of trustees. In case of the non existence of any descendent or on the occurrence of vacancy in the office of any other member the remaining members shall appointed any suitable person to fill up the vacancy.

**PROVIDE THAT** if the successor was not nominated by a decease the life time founder trustee them one of the legal heir as appointed by the family settlement shall be the successor of the such decease. If the successor appointed by the family settlement acts again the sprit and object the trust or may bring bad name to the institution then the family with replace the successor by another suitable legal heir of the such deceased provided further that the approval of the board of trustees shall be necessary for such replacement.

That terms lifetime trustees will mean and include the founder trusted and nominees or legal heir or legal representative of the deceased trustee as above mentioned.

- 16. VACANCIES:** Any office bearer or member of the board of trustees who cease to be a member of is removed from the membership will automatically cease to be an office bearer of the board of trustees.
- 17. FUNCTION OF THE GENERAL BODY:** The general shall meet once in every years, its functions will be:
- i. To consider the annual reports and accounts of the trust and the intuitions there under.
  - ii. To make, add, amend, after or delete any of the objects rules and constitutions of the trust.
  - iii. To trasanct any other business, which the board of trustee may put before it.
  - iv. To consider and confirm the rules and regulation as made and admended or modified by the board of trustees.
  - v. I hold elections after every three years for selection/review of the office bearer out of the lifetime trustees.
  - vi. To appointed of the lifetime bearer each year.
- 18. FUNCTION OF THE BOARD OF TRUSTEES:** The board of trustees shall have complete control over the affairs of the trust under the supervision of the designated chairman. Its function will be :
- i. To make of frame from to time rules regulation for the administration trust and its institutions and also amend or modify them as and when expedient and necessary for smooth can duct of the affairs of the trust.

- ii. The board of trustee shall have powers to dissolve the trust and dispose of the assets and properties those belonging to the trust after discharging all the liabilities of the trust as on that date subject to be condition that such disposal of the assets and properties shall be in conformity with the object and purpose of the trust.  
To administer and supervise all the institutions under the control of the trust.
- iii. To obtain N.O.C.'s form the authorities and get necessary affirmation with the university or board or any other authority.
- iv. To fulfill the conditions as laid down by any government or court or authority or the affiliating university / board etc.
- v. To complete orders and directions issued by the government or any authorizes form time to time.
- vi. To manage financial affairs of the trust in a transparent manner.
- vii. To appoint the auditor of the trust whose term shall be for one year unless re-appointed.
- viii. To do all and or any act to appoint sub committees in furtherance of the aims and object of the trust.
- ix. To grant/fix facilities to be provided to the officer bearers like, accommodation, transportation to the working members.
- x. The proceeding resolution and act of the aforesaid committees shall be subject to the approval and confirmation of board of trustee.
- xi. The board of trustees of the trust will appoint convenor of such sub committees.

- xii. The annual accounts shall be prepared by the board of trustees and with its report, shall be put before general body for its approval.
- xiii. The power appointment, getting leaving, fixation of pay employees including provident fund etc. shall vest with the head of institutions to which employees belongs to.
- xiv. To fix the remuneration/honorarium/salaries of the working founder trustees in there capacity as managerial staff.

To grant fix facilities to be provided for the office bearers like, accommodation transportation and conditions from the employment terms of any working member/trustee.

In delegates its power for a specific purpose to any member/trustee or officer to the trust or its unit or institutions to the extent the board of trustees deems it fit to ensure keeping of clear and proper accounts, receipt and disbursement of the trust fund and shall be responsible for the internal audit and annual audit by a competent auditor and present the audit report to the general body.

- 19. NOTICE OF THE MEETING:** That the general secretary with the permission of the chairman shall call a general body meeting and the meeting of the board trustees, for a meeting of the general body a notice of ten days shall be necessary. A notice of five days shall be necessary for the meeting for the board of trustees. In case of any emerge to frame other terms and conditions from the employment terms of any working member/trustee. In case of any emergency meeting.

A notice for corner period may be given by the consent of the chairman. The accidental omission to given by the consent of the chairman. The accidental

omission to give any information or notice or the non receipt of any information by any manner shall not invalidate the proceedings of any meeting. A proxy form along with the agenda of the meeting shall be circulated to every member with the notice for the meeting.

- 20. QUORUM:** Quorum of every meeting of the board of trustee shall be 2/3 of the strength whereas the quorum for the general body meeting shall 1/3 of the total members. The quorum of the adjourned general body meeting shall be twenty percent of the total strength. The quorum for the adjoined meeting of the board of trustee shall be fifty percent of the total strength. However the chairman if the deem fir may adjourn any meeting despite the fact that the criteria of the minimum quorum was met.

**21. MEETINGS:**

- a. That the annual general meeting will be held once in a year, meeting of the board of trustees shall be held least once in three months. The agenda for the meeting shall be prepared and sent in advance along with the notice for the meeting,
- b. The designated chairman shall preside over every meeting. Each member of the board of trustee shall have vote and all other matter will be decided by simple right of a casting vote.
- c. He shall be the chairman of the board of trustees and governing body of the trust and of all the other committees or sub committees.

**22. CHIEF TRUSTEE DESIGNATED AS VICE CHAIRMAN :**

- a. The vice chairman along with the chairman shall have the power to supervise the board of trustees of the trust of the sub committees of any of the institutions under the control of the trust and can delegate the powers and the functions of board of trustees or committees call an urgent meeting of the general body and

place his report before the meeting for such action as the general body thinks necessary.

- b. In the absence of the chairman exercise the power of the chairman, but he can exercise the financial transaction only after permission of the founder trustee/chairman in writing.
- c. In case of absence of the chairman in any meeting, he shall preside over the meeting and acts as chairman.
- d. He/She will prepare the annual report and put up accounts for information of the general body.

**23. CO - TRUSTEE DESIGNATED DIRECTOR:**

- a. He / She shall assist the chairman and vice chairman in managing and running the affairs of the trust and all its branches and institutions.
- b. In the absence of the chairman, the vice chairman shall preside over the meeting.
- c. That the minutes of the proceeding of the meeting shall be drawn up and kept on record. General Secretary shall authenticate all orders and decisions taken in the meeting.
- d. The minutes of the proceeding of a meeting shall be confirmed, authenticated and adopted in the subsequent meeting.
- e. It shall be necessary to accord the post facto approval and or to take a corrective action for any thing done or decision made, financial or otherwise, by any of the member of the board of trustee or any other officer of the trust or its units beyond his/her power or which would have not being done or made with the majority of the board of trustees.
- f. Any member who has right to attend and vote at the meeting may appoint proxy, who shall have the same voting right. Provided a duty filled in any properly

authenticated proxy from will be furnished at least 24 hours before the meeting to the chairman of the meeting have powers to open, close and operate bank account on behalf of the trust.

**24. POWER AND DUTIES OF FOUNDER OFFICE BEARERS:**

**a. FOUNDER TRUSTEE DESIGNATED AS CHARIMAN :**

- i. The chairman shall have the right to call for examining any document, file or account book of the trust or any of its branches departments or institutions and pass order there on, but copies of all such orders be sent to the officer of such branch or department for information. He will also have the right to correspond with government or any other portion on all matter connected with the trust or its branches and institutions. He shall have powers to open close and operate bank account on behalf of the trust.
- ii. He shall have the power to take all administrative decision and to supervise the affairs of the trust in the interest of the trust.
- iii. Founder trustee / chairman will have special powers that she / he can amend reject or accept the suggestion or decision of any officer, worker of the trust. Chairman can issue any direction and can interface with any of the decision in that case decision taken by chairman will be final an binding to all.
- iv. He shall have the power to exercise all the financial transaction on behalf of the trust.
- v. He shall have the power to supervise to board of trustees of the trust or the sub committees of any of the institution under the control of the trust and can delegate the power and functions of board of trustees or committees call and urgent meeting of the general body and place his report before the meeting for such action as the general body thinks necessary.

- vi. The director shall also perform such other duties and functions as may be authorized expressly in writing by the board of trustees and will report to the board of trustees of the action taken and to the progress about such assignment and the matter.
- vii. He / She shall be responsible for all the matter relating to the employees, legal compliance and follow up with various authorities.
- viii. He / She will have the power of grant leave to the employees at the head office and all other sections or braches of the trust.
- ix. If the trust needs any types of loan, the founder trustee /chairman can take a loan from the bank by pledging the property of the trust.

b. **CO - FOUNDER TRUSTEE DESIGNATED AS GENERAL SECREATARY / TREASURER :**

- i. He / she as the chairman, vice chairman, director and the general secretary in managing and running the affairs of the trust and all its branches and institutions.
- ii. He / She shall also perform such other duties and functions and may be authorized expressly in writing by the board of trustees and will report to the board of trustees of the action taken and to the progress about such assignment and matters.
- iii. He / She shall keep a record of the meeting of the general body and board of trustees and shall issue notice for the meeting.
- iv. To prepare the agendas of the meeting issue the notice for the meeting and conduct the meeting.
- v. He / She shall be responsible for all the matters relating to the employees, legal compliance and follow up with various authorities.

- vi. Custody of assets shall be his / her obligation.
- vii. He / She shall be responsible that accounts are properly maintain and audited. He / She shall be responsible for safe custody of all money, securities and valuable documents belonging to the trust and its branches and institutions. He / She 'keep the money of such institutions in such bank of trustees may direct, provided that all or any of the above mentioned duties and power may be delegated to any member of the trust by the chairman.

**25. ASSETS :**

- a. Trust can sale / purchase moveable immovable assets, keep it as bundage / lease can rent it or can borrower's on rent.
- b. Trust can accept / provide loans, Donets, gifts prizes and honorarium in the interest of the trust.
- c. Trust can invest money can fix it up with bank or can invest money / assets in any of the project, bank, organization or a company.
- d. Trust can purchase and construct building by making use of money received in donation / grant from any organization / person or from government for the purpose of school, college, technical and medical institution in all most all the forms for construction school / college, institute library, hotels, community halls auditoriums building and purchase of equipment, compute, medicines, book etc.

**26. ALTERNATION IN THE CONSTITUTION :**

- a. A change in the constitution shall not be valid unless it is adopted by at least two-third majority of the members present and voting present arid voting at the general body of the trust.

**28. PROVISIONS OF THE INDIAN TRUST ACT 1882 :** That in the matters not specifically provided in this deed of trust provisions of the Indian trust act 1882, shall be apply so for as or in the consonance with the q charitable purpose and the object of the trust.

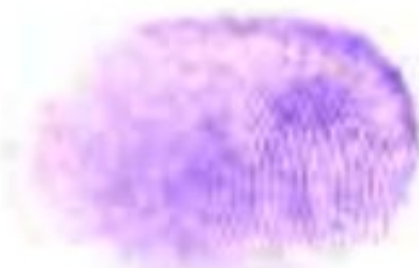

**32. Other restrictions :** Regarding compliance of the following restrictions for recognition from CBSE and ICSE :-

- i. The registered trust of the school will be renewed from time to time.
- ii. The Managing Committee of the school shall consist of one member nominated by the Director of Education.
- iii. At least 10% of the seats in the school shall be reserved for meritorious children belonging to the Scheduled Castes / Scheduled Tribes and they shall not be charged more than the fees prescribed for different classes of the school run by the Uttar Pradesh Board of Secondary Education, Basic Education.
- iv. No grant will be sought from the State Government by the institution and if the school is previously recognized by the Board of Secondary Education and the school is affiliated to the Central Board of Secondary Education, New Delhi / Council for the Indian School Certificate Examination, from the date of receipt of recognition from the Council. And the grant from the state government will automatically end.
- v. The teachers and non-teaching employees of the institution will not be given pay scales and other allowances less than the admissible pay scales to the employees of state aided educational institutions and other devotees.
- vi. The service conditions of the employees will be made and they will be provided with the retirement benefits admissible to the employees of aided non-government higher secondary schools.
- vii. The institution will abide by the orders issued by the State Government from time to time.
